AND whereas it is necessary to get the trust deed registered and declared the objects and terms of the public charitable trust, constituted under these presents:

Now this indenture witnessed as follows:

CREATION OF TRUST:

1. That, in order to effectuate his aforesaid desire, the settler agreed to set apart and hand over to the trustees a sum of Rs. 1,00,000/- [Rupees: One Lacs Only] (hereinafter called the "Trust Fund" which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents) and the trustees agreed to hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained hereto in this deed.

The trust may, however, open its office/sub-offices/Branches at places as may be considered necessary by the Board of Trustees from time-to-time.

4. **OBJECTS:**

A. MAIN OBJECTS:

That the main object for which this trust is established are:

(a) To establish, run, support, develop and maintain schools, colleges, Coaching centre for various competitive Examinations, tests and interview, vocational and professional training institute, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
